DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

Follow all label directions, restrictions and precautions including statements pertaining to the Worker Protection Standards, on the EPA registered Agri-Fos® Systemic Fungicide label.

This label must be in the possession of the user at the time of pesticide application.

To amend the Agri-Fos® Systemic Fungicide label to include applications on:
Oak, Shreve Oak, Coast Live Oak, Canyon Live Oak, Black Oak and Tanoak.
Agri-Fos® Systemic Fungicide may be applied through basal bark spray applied only to listed species.

Basal Bark Application

Mix solution of 21 parts Agri-Fos® Fungicide with 21 parts water solution with 1 part “**Pentra-Bark™**”, CA DPR # 71962-50001-AA. Apply this uniformly to the circumference of the trunk of the tree. Spray from top down to ground level from either first branch or from as high as possible without exposing applicator to drift. Spray to just prior to runoff.

Treatment is generally effective if applied uniformly to 6 to 9 feet of trunk circumference, or from first branch to ground level, depending upon age and infection level of tree. Can be used as a preventative or curative application for trees listed.

Various types of application equipment can be used to apply AGRI-FOS® fungicide solution such as from hydraulic sprayers, handheld pump up sprayers, backpack sprayers, hose end applicators with backflow prevention devices and other similar application devices.

Solution Calculation

For 1 gallon of AGRI-FOS® Basal Bark end use solution:

Mix	62.4 oz. AGRI-FOS® Fungicide
	62.4 oz. water
	3.2 ounces Pentra-Bark™ Surfactant

Mix and apply uniformly to circumference of tree trunk bark surface.

GENERAL INFORMATION

PENTRA-BARK is a superior nonionic wetting agent designed for water based herbicide application in agriculture, horticulture, industrial, turf and forestry operations. It is designed for fast spreading, uniform distribution and absorption of spray on leaf and stem surfaces. During application, insure thorough coverage without excessive runoff.

DIRECTIONS FOR USE

Basal Bark Application: For use only with **Agri-Fos Systemic Fungicide** in the treatment of Sudden Oak Death.

MIXING

Spray mixing and application equipment must be cleaned according to cleaning directions on prior pesticide label before application.

To minimize and help prevent foaming, fill tank 2/3 to 3/4 full of water. Add pesticide as directed by label.

While agitating, add **PENTRA-BARK** and mix for 1 to 2 minutes with lower than normal agitation. Continue filling tank maintaining minimal agitation. For most effective results, apply within 36 hours after mixing.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. Do not store near heat or open flame. Store in original container.
